*** FREESTYLE OPTIONS ***					
<p>General Rules: Skaters may choose one of three freestyle ice options. Skaters may skate any number of freestyles each so long as total number of freestyles skated during contract period does not exceed maximum number of sessions indicated for option chosen. All freestyles on any option must be during this contract period. Unused freestyles will not be carried over to subsequent contract periods or refunded. Freestyles may be used during club freestyle time but must be used in .5 hour, 1 hour, 1.5 hour or 2 hour increments. Skaters will be required to check in and out each day and time used will be calculated at the most recent 1/4 hour. Example: If your skater checks in a 5:47 for 1 hour, their time will start at 5:45 and the hour will expire at 6:30. Weekly freestyles times: Sunday 4:15-6:15 pm, Monday 6:30-7:30 pm, Thursday 5:30-7:30 pm</p>

	Skate an average of 1 freestyle per week. Total freestyles skated during contract period cannot exceed 12. (Average cost per freestyle \$16.50)				
	3 Freestyles per week - 36 total sessions				\$ 450.00
	Skate an average of 3 freestyles per week. Total freestyles skated during contract period cannot exceed 36. (Average cost per freestyle \$12.50)				
	5 Freestyles per week - 60 total sessions				\$ 570.00
	Skate on all freestyle sessions offered during the entire contract period. (Average cost per freestyle \$9.50)

A signed ice contract must be received by CVFSC before skaters are allowed on Club Ice. A \$25.00 late fee will be assessed to skater's account if Ice Contract and 1/2 payment are not received by 9/12/2016. Previous ice contracts must be paid in full before being allowed to contract additional ice time. Even if not skating, the skater will be responsible for paying contracted ice time unless release of this contract is approved by CVFSC Board of Directors.
